C. Discussion, Consideration and Possible recommendations of Proposed Legislation.

- SB 1006, allowing licensee's 180 days to renew once returned from active Guard and Reserve Duty by application and without penalty.
It appears this bill will pass.
- SB 1134 Naturopathic physicians board (Identifies Cosmetology Board as a Self Supporting Regulatory Agency and as an appealable agency).
Signed by the Governor.
- SB 1236 Relating to the Board of Homeopathic and Integrated Medicine Examiners. ARS 41-1092 (7) (g), identifies Cosmetology Board as a Self Supporting Regulatory Agency and as an appealable agency.
Signed by the Governor.
- SB 1300 transfer \$1,091,800 from the Board of Cosmetology Fund to the General Fund.
The original bill was vetoed by the Governor. The bill was amended raising the amount from the Board's account to \$3,091,800. This version passed and was signed by the Governor. An additional \$13,000 was subsequently taken as the Board's portion of savings due to the imposed hiring freeze.
- SB 1321 and House Bill HB2697 relating to Body Art Establishments; Exemptions for Aesthetics, Cosmetology, and Nail Technology and regulated by the State Department of Health. Provision requires a separate establishment license and regulation within cosmetology salon premises.
This bill is considered dead.
- SB 1419 Cosmetic procedures; Lasers; Injections; Regulation.
Will go to the Governor on Monday.
- HB 2082 state employee compensation; joint committee. **Appears to be Dead.**
- HB 2462 **postsecondary education commission; duties** (Adding a Barber member to the Commission for Post Secondary Education and does not change the Cosmetology Accredited School Representative Member). **Passed**
- HB 2552 Board of Barbering and Cosmetology. **Dead**
- HB2632 Public Supervisors; Eligibility Violations; Penalties. **Dead**
- HB2637 Salons and Barber Shops exempted from paying Municipal Tax on services. **Dead.**
- HB2697 body art establishment; licensure. **Dead**

D. Report and Discussion on Regions 3 & 4 held in Salt Lake, Utah on April 26th & 27th, 2008.

Sue Sansom, the Executive Director, reported that the meeting was awesome and a new owner of Kings Research, the company that produces Barbicide, was present. Barbicide has new "wipes" that are a disinfectant; however, Kings Research supports the NIC complete immersion of tools position. Stephen Colarusso, Chairman of the Board, commented that the NIC website has been redesigned and has been done very well.
