The Assistant Attorney General, Bridget Harrington, gave the Board members a copy of a letter written to the Governor regarding an exception to the moratorium on rule making. Ms. Harrington explained that if a rule change did not impose further costs it is possible that a rule change may be allowed, with proper explanation, during the moratorium.

The Executive Director, Donna Aune, informed the Board that she will call the agency's contact at the Governor's office to get direction on whether or not any action has been taken on the letter and if the Board can move on with the rule change.

The Assistant Attorney General, Bridget Harrington, reported that Ms. Vong is appealing the decision.

The Assistant Attorney General, Bridget Harrington, explained that at this time the Board has statutory authority to approve qualified applicants for licensure and because of the high number of licenses issued per month (6,389) the Board has delegated that authority to its Executive Director. For purposes of clarification, the Board could consider putting the authority of the Executive Director to issue licenses only to qualified applicants in statute.

**EXECUTIVE DIRECTOR’S REPORT \*, \*\*, \*\*\* AND \*\*\*\***

**A. Summary of Current Events.**

Nancy Lease of Empire Education Group reported to the Board that schools are going to be asked to prove that they are providing education which leads to “gainful employment”. There is a comment period at the American Association of Cosmetology website and urged participation in this comment opportunity.

The Executive Director, Donna Aune, announced that the agency has another mandatory furlough day on Friday, August 20, 2010. This is another 8 hours without pay for all employees.

Ms. Aune also reported that she and several staff members went to the Motor Vehicle Division to see firsthand their process on placing pictures on licenses, which is a goal of the agency. The agency’s computers would need upgrades and additional software to accomplish this task.
